"The term buccaneer is generally used now to describe the privateers and pirates of the West Indies who raided Spanish towns and shipping in the Caribbean and along the coasts of Central and South America in the period from around 1600 to the 1680s. The word originally applied to the groups of men, mainly French, who lived off the wild herds of cattle that roamed the northern regions







of Hispaniola. They became known as boucaniers or bucaniers from their practice of roasting meat on a boucan, a type of barbecue, in the manner of the local Indigenous people. Armed with an assortment of weapons and dressed in bloodstained hides, these rough men were described by a French missionary as the butcher's vilest servants who have been eight days in the slaughterhouse without washing themselves. Driven off Hispaniola by the Spanish in the 1630s, they migrated to the rocky island of Tortuga and used this as a base from which to attack passing ships and particularly those of the hated Spanish. After the capture of Jamaica by the British in 1655 many of the buccaneers moved to the harbor and town of Port Royal, which soon acquired the reputation of being the wickedest city in Christendom. The successive Governors of Jamaica encouraged the buccaneers to base themselves at Port Royal and issued privateering commissions for their ships. The buccaneers' presence protected the island from attack by the French or Spanish; and the ships and loot which they seized were of considerable benefit to the island's economy." 

- In 1932 the American scholar John Robert Moore announced at a literary meeting that after years of careful research he believed Captain Charles Johnson was the anonymous pen name for the novelist, journalist, and sometimes historian, Daniel Defoe. Professor Moore's reputation as the leading Defoe scholar convinced libraries around the world to recatalog A General History of the Pyrates with the author's name as Daniel Defoe. But in 1988 two scholars, P.N. Furbank and W.R. Owens, disputed the plausibility of Defoe as the author in their book The Canonisation of Daniel Defoe. Many scholars today accept the conclusion that Defoe could not have







penned the book, but there are those who also believe otherwise. The editor of the 1999 edition of *A General History of the Pyrates*, Manuel Schonhorn, believed Defoe was the author and dedicated the first five pages of the introduction to Defoe's life, works, and maritime interests. Although the identity of the author is unclear, it is certain that the book has greatly influenced the popular opinion of pirates from the eighteenth century to now. 
